If the PASP does not proceed to ASP within 5 working days after the date on which the PASP is entered into, in order to fulfill the requirement under section 59(2)(c) of the Residential Properties (First-hand Sales) Ordinance, vendor may state "the PASP has not proceeded further" in column (B) on the sixth working day after that date.

 - (ii) a private company of which such a partner, parent, spouse, child is a director or shareholder.

- (v) This obligation is given on an entirely without prejudice basis and as a gesture of goodwill of the Vendor. For the avoidance of doubt, the Vendor bears no liability to the Purchaser for any failure or delay to perform this obligation. - (vi) Without prejudice to the generality of the foregoing, this obligation is not applicable to any defects caused by vandalism, wrongful act or negligence or normal fair wear and tear and the Vendor is not responsible for the remedy of any defects arising out of or resulting from improper operation or maintenance, or for defect or damage aggravated through failure or delay in giving notice to the Vendor. This obligation shall cease to be applicable and the Vendor shall not be obliged to carry out this obligation if and when the subject matter of the

- (vii) In the event that any alterations to the Property and/or any matter added to the Property after the completion of the sale and purchase of the Property will hinder the Vendor from carrying out the remedial work of the defects (in which respect the Vendor's assessment and decision shall be final, conclusive and binding absolutely), the Purchaser shall be responsible for removing such alterations or additions prior to the commencement of the remedial works and restore such alterations or additions after completion of the remedial works at the Purchaser's own cost. The Purchaser shall submit an application form prepared by the Vendor for the Early Move-in Benefit to the Vendor no earlier than the 31st day after the date of the Preliminary Agreement.
